### About this document

This document is a portion of the Supportive Services and Treatment for Accessible Recovery – Together (START) for Pregnant and Postpartum Persons and Their Families Notice of Funding Opportunity (NOFO), which sets forth application requirements for applicants to establish or expand comprehensive, holistic services to support pregnant and postpartum people with opioid use disorder and other substance use disorders (OUD/SUD), their families, including small children, and infants with Neonatal Opioid Withdrawal Syndrome (NOWS).

# A.5. Scope of Services

START subrecipients will establish or expand comprehensive, holistic services to support pregnant and postpartum people with opioid use disorder and other substance use disorders (OUD/SUD), their families, including small children, and infants with Neonatal Opioid Withdrawal Syndrome (NOWS). These services should be available for up to 12 months after birth and should address social determinants of health (SDOH), access to treatment, and recovery support services.

## **Task 1. Fulfill Award Administration Requirements**

The subrecipient must fulfill obligations outlined in Section G of the NOFO, including planning, reporting, data collection, and participating in technical assistance (TA).

### **Task 2. Conduct Needs Assessment**

The subrecipient must conduct a needs assessment to identify the types and levels of treatment, recovery support services, and comprehensive wraparound services that are available to the population of focus, and the areas of unmet need. The needs assessment should evaluate health disparities and the related social and economic inequities that impact access to and need for services. Within 90 days of award, the subrecipient must submit a written needs assessment report.

# Task 3. Develop Program and Workforce

The subrecipient must establish and staff multidisciplinary teams including community outreach workers, peer support workers, and doulas. The composition of the teams must be designed to meet the complex needs of pregnant and postpartum people and their families, including engagement, retention, and addressing challenges accessing services.

The subrecipient should strive to hire and train staff who reflect the diversity of the population receiving services. Inclusion of management staff is dictated by the size and scope of the program. Many variables will impact the number of FTE to be hired. Up to .1 FTE of management time may be included per 1 FTE staff. However, staffing should be justified in your application and budget narrative. Teams shall be staffed within 90 days of award.

The subrecipient must help expand the peer support worker and doula workforce, including the following:

- (a) Support peer support workers who are not currently certified in obtaining <u>Certified Recovery Support Specialist (CRSS)</u>, <u>Certified Peer Recovery Specialist (CPRS)</u>, <u>and/or Certified Veteran Support Specialist (CVSS)</u> credentials, including payment of costs.
- (b) Support doulas in the <u>certification process</u>, including payment of costs.
- (c) Provide technology options to provide recovery support services via phone or video.
- (d) Provide peer support workers access (in person or through technology) to clinicians (e.g., LCSWs, LCPs, or physicians) for case consultation, crisis intervention, specialized resources, and support.
- (e) Pay peer support workers and doulas living wages and provide typical benefits, such as paid time off; medical, dental, and vision insurance; and retirement contributions.
- (f) Train staff on Mental Health First Aid, Motivational Interviewing, domestic violence, home visiting, and trauma-informed care during the onboarding process.



# Task 4. Engage Participants in Medical and Behavioral Health Care

The subrecipient must engage the population of focus, using Motivational Interviewing (or similar techniques) and warm handoffs, in the following services:

- (a) Primary medical care, including referral for prenatal care and, while the pregnant person is receiving such services, childcare.
- (b) Primary pediatric care, including immunizations, for their children.
- (c) Gender-specific substance use treatment and other therapeutic interventions for women which may address issues of relationships, sexual and physical abuse, and parenting, and childcare while women are receiving such services.
- (d) Therapeutic interventions for children in the custody of women in treatment which may, among other things, address their developmental needs, their issues of sexual and physical abuse, and neglect.
- (e) Sufficient case management and transportation to ensure that pregnant persons and their children have access to the services provided by items 1-4.

If the subrecipient already provides any of the above services using other funds, it must continue to do so and may not supplant existing funding. To the extent that any of these services are unavailable in the community, they may be provided as described in Optional Task 4 below.

## Task 4a. (Optional) Deliver Medical and Behavioral Health Care Services

If the needs assessment demonstrates that the services detailed in Task 4 are inaccessible for the target population, up to 20 percent of the award may be expended to supply such services to the extent that such an expenditure would not supplant existing federal or state funding, would comply with applicable service regulations, and address the OUD/SUD.

Before allocating or spending any funds for these purposes, the subrecipient must submit the needs assessment and revised budget (Task 2). The subrecipient may not expend funds in any circumstance in which other forms of reimbursement are available.

When providing SUD treatment, the subrecipient should:

- Consider positive and negative familial and partner influences and relationships
- Promote a safe and caring treatment environment
- Consider the whole person, including family and parenting responsibilities
- Include screening and assessment for trauma history
- Identify and address co-occurring substance use and mental disorders, such as mood, anxiety, and eating disorders
- Incorporate medications (methadone or buprenorphine) according to current clinical guidance of the American College of Obstetrics and Gynecology (for pregnant persons) or SAMHSA
- Recognize cultural expectations to help improve engagement and retention



# **Task 5. Provide or Link to Supportive Services**

The subrecipient must provide, or establish linkages to, the following services:

- (a) Case management to assist in establishing eligibility for public assistance programs
- (b) Employment and training programs
- (c) Education and special education programs
- (d) Housing for pregnant people and their children
- (e) Prenatal care and other healthcare services (including screening for pregnancy)
- (f) Therapeutic day care for children, Head Start, and other early childhood programs
- (g) Transportation needed to accommodate the seven required services listed above

Programs providing these services must treat the family as a unit; be strength-based; follow a multi-disciplinary approach; be trauma-informed; be culturally responsive; use a self-in-relation model; and ensure all staff have continued, focused training in areas such as domestic violence and/or intimate partner violence that meet the needs of the population of focus.

### Task 6. Participate in Learning Collaborative

The subrecipient must participate in a learning collaborative to support the systems integration of SUD and co-occurring disorder treatment and recovery, maternal-child health, and early childhood development.
